ALT 92.3 'S "DAVID BYRNE" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WZRH-FM ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 201 St. Charles Ave, Suite 201, New Orleans, LA 70170, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

Station's decisions as to the administration and operation of the Contest.
