ALT 92.3 'S "WEEZER/PIXIES" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WZRH-FM ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 201 St. Charles Ave, Suite 201, New Orleans, LA 70170, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

All entries must be received by 11:59 pm CST on May 17, 2018 to be eligible for the Grand Prize drawing. Limit one (1) entry per person per day per email address. Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. Station's decisions as to the administration and operation of the Contest.
