ALT 92.3'S "3 DOORS DOWN" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WZRH-FM ("Station"), owned and operated by Cumulus Radio Corporation located at 201 St. Charles Ave, Suite 201 New Orleans, LA 7010, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

Eligibility. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.
