ALT 92.3'S "WEEZER/PIXIES WEDNESDAY" CONTEST OFFICIAL RULES

- a. A complete copy of these rules can be obtained at the offices of radio stations WZRH-FM ("Station"), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 201 St. Charles Ave, Suite 201 New Orleans, LA 70170, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

- 2. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - a. Eligibility. This Contest is open only to legal U.S. residents, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number and who reside in the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, who have not won a prize from the Station in the last **24 Hours** or a prize valued at \$500 or more in the last 24 Hours and whose immediate family members or household members have not won a prize from the Station in the last 24 Hours or a prize valued at \$500 or more in the last 24 Hours. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 3. Contest Period. The Contest will begin at 5:00pm CST on May 31, 2018 and will run through 7:59pm CST on June 14, 2018 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- **4. How to Enter.** To enter:
 - On-Air: Listen to the Station during the Contest Period. When the Station gives the "cue-to-call", listeners should call the Station at (504) 260-9292. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will be entered to win. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
- **5. Winner Selection.** Station will select one (1) winner per hour between 10:00am CT and 5:59pm CT. Caller nine (9), as described above, will be notified at the time of his/her call. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest.
- **6. Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING

IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) in order to claim his/her prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
