ALT 92.3'S "IMAGINE DRAGONS SUITE" CONTEST OFFICIAL RULES

- a. A complete copy of these rules can be obtained at the offices of radio stations WZRH-FM ("Station"), owned and operated by Cumulus Radio LLC., 201 St. Charles Ave, Suite 201 New Orleans, LA 70170, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification.

- 6. Verification of Potential Winner.
